HOW TO RENEW:

1. Choose your Membership Type:
 - (a) You are a **SINGLE** member paying \$77.00 Cdn annually.
 - (b) You and one member of your family can hold a **FAMILY** membership for \$87.00 Cdn annually. Family memberships receive only one copy of all publications from the UK and Canada.
 - (c) If you are 65+ years of age, you can become a **SENIOR** member for \$67.00 Cdn annually. Two **SENIOR** members (both 65+) living at the same address can hold a **SENIOR FAMILY** membership for \$77.00. You will receive a single copy of all publications from the UK and Canada. **NOTE:** *The age for Senior member changed in October 2021. If you became a Senior member at age 60 between 2016 and 2020, you may retain this level.*
 - (d) If you are a full-time student (high school or post-secondary) you can become a **STUDENT** member for \$67.00 Cdn annually. You will receive all publications from the UK and Canada, and invitations to meetings.
 - (e) If you already pay your membership fees directly in £ Sterling to the Richard III Society in Britain, you can become an **AFFILIATE** member of the Richard III Society of Canada for an additional \$25.00 Cdn. You will then additionally receive the *RIII* from the Canadian Branch and invitations to Branch meetings. Please provide us with your British membership number for confirmation (this number is found on your *Bulletin* mailing insert and your membership card).

PLEASE TAKE NOTE OF THIS ALTERNATE MEMBERSHIP CATEGORY: *BRANCH ONLY* member

For \$25.00 Cdn, this member would receive:

- 3 issues of the *RIII* by email
- Access to the Buyers Library in Toronto
